CONFERENCE ON HOLOCAUST DISTORTION AND EDUCATION: CURRENT AND EMERGING CHALLENGES NATIONAL MEASURES IN PLACE

28-29 October 2024

Bucharest, Romania

The current climate calls for a fresh look at Holocaust education, including the potential impacts of artificial intelligence (AI) in this space and how to use traditional education in all its forms (classrooms, museums, memorials, public art), as well as current day platforms, to advance public knowledge of the Holocaust and confront Holocaust distortion.

The conference will showcase Romania's leadership on Holocaust education for countries in Eastern and Central Europe, recognizing education's key role in confronting Holocaust denial and distortion and other forms of antisemitism.

Featuring experts, educators and officials, the conference would engage on the realities of teaching the Holocaust today with emphasis on lessons learned and address how the October 7th Hamas attacks and the ensuing Israel-Hamas war affect Holocaust education. It seeks to raise awareness of the capacities of technologies and explore competing and conflicting historical narratives.

The conference could consider not only best practices in classrooms and public institutions, including museums, but also whether AI can also be used as an educative tool to counter Holocaust denial and distortion. It will also examine the success (and failure) of national efforts to address current challenges and combat anti-Semitism.

HOLOCAUST DENIAL AND DISTORTION – NEW

CHALLENGES

Although the rise of Anti-Semitism has been constant in the recent years against the background of the situation in the Middle East since the Hamas attacks against Israel in October 2023 and the ensuing Israel-

Hamas war we have witnessed an unprecedented wave of threats and incidents against members of Jewish community worldwide, both online and offline. The discussion would assess emerging technologies such as AI and their current impact and possible positive role in countering Holocaust distortion and denial. Areas of examination: how to counter misuse of AI and what options exist to use AI for good, especially as a potential tool to reach wider audiences. Additionally, the session could address restrictions on research and efforts in some countries to rehabilitate fascist-era leaders who were complicit in the crimes of the Holocaust as well as look at how the Holocaust has been weaponized following the Hamas terrorist attacks in October 2023 and the ensuing Israel-Hamas war.

SESSION II

ADVANCING HOLOCAUST EDUCATION IN CHALLENGING TIMES

Designed to connect educators with policy makers, the session could assess advances in educational curricula and the training of teachers, civil servants, as well as public commemoration ceremonies and programs, national legislation, and/or other initiatives by Holocaust museums and institutions. It should offer recommendations to overcome existing challenges to education about the Holocaust, best practice examples, relevant survey data on knowledge, and where available, critical assessments of the effectiveness of these efforts. This session would showcase Romania's work in public education and the contributions by others, including institutions like the U.S. Holocaust Memorial Museum and others, as well as IHRA resources. The session would seek to spotlight civil society efforts to address challenges when governmental efforts are unable to meet all the needs (i.e., work of Centropa, TOLI). This session could also provide an opportunity for policy makers to hear directly from educators on their experiences considering recent events in Middle East. The role of civil society—and hearing from regional NGOs in this field—would be a critical aspect of the discussion.
